2. Accounts not paid within 10 days from due date may be placed on COD basis until the account is paid in full. In the event of default and referral to an attorney or collection agency, purchaser agrees to pay all costs of collection, including reasonable attorney fees. Purchaser applicant agrees to pay such sums upon demand of Seller. Venue for any litigation relating to goods sold to the undersigned shall be in Beaumont, Jefferson County, Texas.
3. Finance Charges on accounts with any balance past terms will be assessed at the rate of 1½% per month (annual percentage rate of 18%), pursuant to the annualized ceiling rate set forth in V.T.C.A. Finance Code Section 303.009(a).
4. Statements are payable to RPA Roofing Supply, at P.O. Box 1182 Bridgeport , TX 76426 . Customer authorizes RPA Roofing Supply, at any time and from time to time, to obtain and use Credit Reports or other credit information on Customer. Customer further agrees to supply such additional information as may be required by Seller to warrant the future extensions of credit or to enable Seller to perfect liens or to recover upon any bond issued. Seller and Customer agree that Customer is not a "consumer" under State and Federal Law and all extensions of credit are for business purposes only.
